The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

#### TRIAL REGULATIONS

**ENTRIES CLOSE AT THE TRIAL SECRETARY'S OFFICE**, by 6:00pm, Wednesday, April 28, 2021 after which time entries cannot be accepted, altered, canceled, or substituted. Make check payable to ALL BREED TRAINING CLUB OF AKRON, INC. (A.B.T.C.A.). Canadian exhibitors must have fees payable in US Funds

**RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of each returned check.

**ENTRY FORM MUST BE SIGNED** at the bottom by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted. **OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.

A RECORDING FEE OF \$.50 is to be collected on the first entry only for each dog, each day. An Event Service fee of \$3.00 will be required for each regular class each dog is entered at any Licensed or Member Club Show Obedience Trial and a \$3.00 service fee for additional entry of same dog. An event service fee of \$3.50 will be collected on the first entry of each dog and a \$3.00 fee on each additional entry of same dog for Rally Trial. These Fees are to be collected by the show giving Club and paid to the American Kennel Club. (AKC Rule, Chapter 11, Section 2).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE 1 hour prior** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes, or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

NO ENTRY SHALL BE MADE and no entry shall be accepted which specifies any conditions as to its acceptance.

DOGS NOT REQUIRED FOR FURTHER JUDGING will be excused.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.

The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL AWARDS MUST BE CLAIMED** at the Trial or they become the property of the All Breed Training Club of Akron, Inc. None will be mailed.

**ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring.

All handlers must clean up after their own dog.

#### **COVID-19 GUIDELINES**

- 3. Masks must be worn in the building and in all rings. Bandanas will be permitted in addition to masks. Either must cover your nose, mouth, and chin to protect others.
- 4. Social Distancing **MUST** be adhered to.
- 5. Shows are **CLOSED** to spectators.
- 6. No children under the age of 18 unless they are showing a dog.
- 7. Do not arrive earlier than one (1) hour of your judging time.
- 8. Our Committees reserve the right to wipe down and disinfect any common areas which are viewed to have been touched excessively.
- 9. **NO FOOD** will be served. NO FOOD/BEVERAGES allowed on ring mats. You are welcome to bring your own snacks and/or meals.
- 10. Due to social distancing, LIMITED crating will may be available, 1<sup>st</sup> come 1<sup>st</sup> served. Please consider crating in your car and bring your pop-up tents for shade.
- 11. Bring your own chairs. No chairs will be supplied by ABTCA.
- 12. NO CRATE SET-UP ON THURSDAY. Crates MUST be placed on your mats and removed after your entered classes are complete EACH day.
- 13. No flexible leashes allowed as this would go beyond the 6-foot social distancing.
- 14. You must pick-up after your dog.
- 15. ABTCA has the right to cancel this trial at any time. If the trial is cancelled, and you have already entered, your check will be shredded.
- 16. If the State of Ohio, Gov. Mike DeWine, or the AKC makes changes according to COVID-19, we will abide by the Governor and/or the AKC changes.
- 17. The COVID-19 Release must be signed, dated, and returned with your entry.
